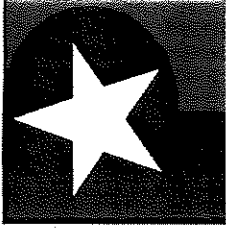
- 1) The Board reviewed and voted to accept the Minutes of the 10/21/14 Meeting. 3-0
