for his trade or occupation, beasts of the plough necessary for the cultivation of his improved land willtown
arms, uniforms and equipments, utensils for housekeeping necessary for upholding life, and bedding and apparel necessary for himself and family. And the goods so distrained by you, you are required to keep, at the expense
of the owner, for four days at least, and within seven days after the seizure you are required to gell them by
public auction for payment of the amount due as provided by law, having first posted a notice of the sale in
some public place in the town at least forty-eight hours before the sale; provided, however, that you may, if you shall see fit, once adjourn such sale for not more than three days, in which case you shall forthwith post a
notice of such adjournment at the place of sale. And upon demand you are to give a written account of every
sale on distress or seizure and of charges, and if said distress is sold for more than the amount due you shall
bay to the owner any surplus above the tax, interest, and charges and fees as provided by law And if you can
not find sufficient goods on which the tax may be levied, you may take the body of the person assessed and commit him to jail until he pays the tax, interest, and charges and fees as provided by law, or until he is dis-
charged therefrom according to law.
