- 2) The Board reviewed and signed the Real Estate and Excise Tax warrants to collect.
- 3) The Board reviewed and signed the Supplemental Tax Warrant and Commitment to collect.
- 4) The Board reviewed, discussed and voted on the following Abatement Applications:

<u>124 Riverlin Street, Cedeno</u> – Filed due to an increase in value of approximately \$20,000. Sandy reviewed the history and found a change in Depreciation from Avg. to Good. Sandy inspected the property on 7/18/2012 and found it to be in Avg. condition. Board voted 3-0 to approve abatement.

273 Southwest Cutoff- Triple B&P Realty LLC — Owner feels property is over valued as building is vacant and has no central heat. Owner feels lot should be valued at \$75,000. Land is located in a commercial zone along Rt. 20 and valued at \$105,000. Building is valued similar to a large garage at \$42,000. Board voted 3-0 to deny.

<u>Dwinell Road, Bonaventura</u> – lot was deemed unbuildable last year. Sandy incorrectly entered a value code into Vision, thus over valuing the parcel. Sandy to correct entry. Board voted 3-0 to correct the value and grant the abatement.

<u>221 Riverlin Street, LMB, LLC</u> – House on lot was demolished as of 9/27/12. Sandy inspected the property. House is gone. Board voted 3-0 to abate the tax on a pro-rated basis.

<u>53 Sycamore Street, Anderson</u> – Due to a deed mix up, owner is being double taxed for the same piece of land. Board voted 3-0 to reduce the house lot by .55 acres as it is now on a separate deed. The Board also voted 3-0 to lower the value of the separate lot to reflect its unbuildable status.
