Sandy inspected the property and also provided the Board with a plan showing the extent of the wetlands. The Board reviewed the plan and concluded that the "highlands" to the rear of the lot has potential to be built on. However the access is across a substantial amount of wetlands which would be costly. The Board voted 3-0 to change classification of the "highlands" to Potentially Buildable and the remainder to Non-Buildable.

- 7) The Board reviewed the request from the Town Manager, Robert Spain to release monies form the current overlay surplus. The Board discussed the matter then requested clarification on how the amount of surplus was calculated, from Financial Director Brian Turbitt. Brian provided the necessary information. The discussed the request. A motion to grant the request was made, second and voted 3-0 to release \$426,000 from the overlay surplus to the Town. Sandy is to follow up with the formal procedure of informing the Financial Director that the request was granted.
