
Absent:

The board acted on the following:

- 1) Board reviewed and signed minutes of 7/18/12 Board meeting.
- 2) Excise and Personal Property Tax warrants reviewed and signed.
- 3) FY 2012 Veterans Exemption applications signed.
- 4) Board reviewed the following Uncollectable taxes: Boat excise taxes, Auto excise taxes and Personal Property taxes. Board signed off on the Boat and Auto excise taxes. The Board discussed the personal property uncollectable taxes. All felt that a portion of these taxes could be collected. Board voted 3-0 not to sign off on the Personal Property uncollectable.
- 5) Board apprised that the lawyer, Mr. Gaines, for 8 Latti Farm Road has filed with the ATB seeking relief from the present assessment. I informed the Board that I've had contact with Mr. Gaines who informed me that his client would withdraw the filing if the Board was willing to settle at a value of \$2.7 for the 2012 assessment. The Board discussed the issue and voted 3-0 to settle at the \$2.7 value. Sandy to contact Mr. Gaines and process the abatement.
- 6) Board reviewed information regarding the AT&T settlement. The Board reviewed the agreement. Sandy pointed out that according to the information provided, that in agreeing to the terms AT&T would withdraw its ATB filing and the Town's exposure would be zero dollars for the wireless case. The Board discussed the matter and voted 3-0 to agree to the settlement. Chairman of the Board Jude Cristo signed the agreement. Sandy to follow up with the Financial Director and Town Manager to see if for any further signatures are needed. Sandy will process and send the signed agreement to AT&T.
- 7) The Board was provided with and signed for the annual List of Residents booklets.
- 8) The Board was presented with the Town's harassment policies. After discussion all agreed to delay signing their acknowledgements of receipt of the policy.
- 9) Motion by G. Valery to adjourn meeting at 6:50. Motion second by J Coggans and carried 3-0.


