The board acted on the following:

- 1) Board reviewed, voted 3-0 to accept and signed minutes of 9/04/12 Board meeting.
- 2) Board reviewed August Real Estate Sales report.
- 3) The Board discussed rescheduling the upcoming October 3rd meeting due to a conflict. Board voted 3-0 to change meetings to October 16 and October 30th. Sandy to fill out necessary forms to schedule the change.
- 4) The Board was presented with request from Murphy Custom Homes to change current bedroom count of 78 S. Oxford Road from two bedrooms to three bedrooms. Sandy informed the Board that no one from the office had ever inspected the interior of the property. I was able to inspect the interior on Monday. Based on the current Millbury definition of a bedroom the property could be three bedrooms. Motion made to change bedroom count to three bedrooms was made and carried 3-0. Sandy will make the change in our records and notify the Builder.
- 5) The Town of Sutton's BOA arrived at approximately 6:30. Attending were Robert Nunnemacher (Chairperson), Ray Nichols and Joyce Sardagnola. Several particular properties were discussed, Orsi Barn, Crestview Drive and Ramshorm Rd. Orsi barn will transfer January 2013. Sandy will research Crestview and Ramshorm. Ways to determine actual boundary were discussed. Both towns tentatively agreed to look into having Hemlock Street surveyed with both towns sharing the cost. A discussion was held on developing criteria for home owners who dispute the findings to be able file a complaint. Robert N. due to his surveying background will develop the bulk of the criteria. Both towns agreed to further meetings in November in order to continue discussions.

Joe C. motioned to adjourn the meeting. Motion carried 2-0 (George Valery left early due to an obligation), meeting adjourned at 7:50pm.
