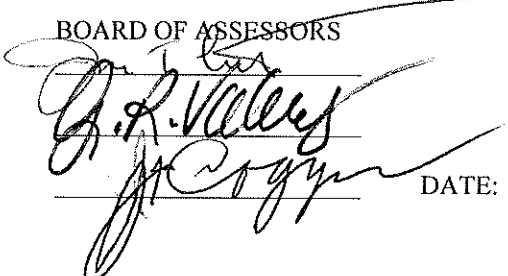

The Board acted on the following:

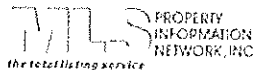
- 1) The Board reviewed and voted to accept the Minutes of the 10/7/14 Meeting. 3-0
