She remarked that the Cemetery Commission needs these amounts in order to make appropriate decisions prior to the end of the fiscal year, and if this information is not provided the Commission may pursue the matter with the state.


ITEM SEVEN – ADJOURNMENT

At 5:40 p.m. Randy Mogren motioned to adjourn the meeting, Marcia Landry seconded. Meeting adjourned.



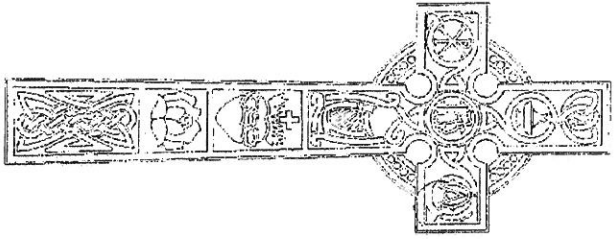
