At 5:15 p.m. Marcia Landry motioned to adjourn the meeting, Gil Picard seconded. Meeting adjourned.





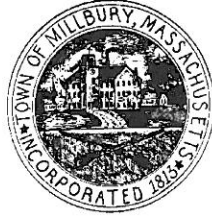
