CEMETERY COMMISSION MEETING MINUTES

November 18, 2013

5:00 PM

Present: Marcia Landry, Randy Mogren, Rob McNeil, and Cindy Allard - Absent: Gil Picard

5:00 pm

Brief discussion on the \$200.00 Cemetery Fee that Selectman Cristo is calling a tax. Both Marcia and Randy attended Selectman's meeting and discussion was had. Selectman requested we re-consider the \$200 fee. Marcia proposed a warrant article at Town Meeting for additional funds for the cemetery. The Cemetery Commission has 3 options regarding the fee, Keep in mind the fees have not been changed in 20 years

- a. Rescind vote
- b. Wait till Town Meeting
- c. Warrant Article stating the fees that are collected be put into a revolving fund so the monies can be used only for the cemetery.

Marcia stated she could go either way on the \$200 dollar fee, Randy stated he would like to stay with the fee. But they both decided to table the discussion to next meeting when Gil is back.

Granite Stairs: located in old part of Cemetery, Rob did speak to Building Inspector and he viewed stairs, he stated we need to do nothing with the stairs; this is per the Building Inspector, Scott Barbato.

Electronic Record Keeping: first crack at it, have it on paper, Rob needs to review so we can move forward.

Dirt pile behind fence at Section 8, had DPW crew clean it out and want to place cement barriers there so no one can keep putting dirt there. The dirt gets pushed back which is an issue with Conservation. Spring time we would like to loam and seed it, Marcia suggested possibly putting more fencing up there, and Rob advised not a good idea.

Also in Section 8 there is a redsox license plate on the fence that needs to be removed, will notify Operation Manager in the am.

Meeting Minutes: minutes for August, 12, September 9 and October 7, were read and Marcia made motion to approve as written, 2nd by Randy, all in favor.

Rules and Regulations: Marcia advised she is off work for a few weeks so she will get the Rules and Regulations written with a draft of the new fees, and will have it for next meeting.


Annual Report has been submitted and the fees are as follows:
