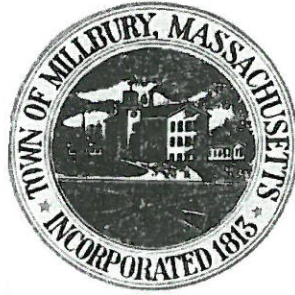

Call to Order: James Morin called to order the meeting of the Millbury Board of Health at 4:00PM on April 12, 2017 in Millbury Town Hall Board of Health Office.

Approve Minutes: MOTION: Ron Marlborough made a motion to accept the minutes. Seconded by Jim Morin. All Approved.

Vouchers Reviewed:

Office Update: Judy mentioned the sharp kiosk is dangerous and we need a new OSHA certified kiosk. The board asked to get more pricing. Cheryl will look into this. Judy mentioned that she does not want to accept sharps in the office and has created a sign. The board agreed and suggested a sign at the kiosk "No Sharps beyond This Point".

13 Wildwood – Judy mentioned that a resident complained about his well water and felt it was potentially contaminated by a neighbors scrap metal pile. We recommended he have a water test done and or hire a professional for guidance and send us the results for review.

Public Health Nurse Update: Cheryl stated she received an email from Phil in regards to a potential food borne illness after a group of students went to a mall restaurant and then at least one was sick at a school play. The mother of the student stated everyone in the group was sick though that was not confirmed. The student was sick on 3/31 and called on 4/9. The entire household was sick. Possible norovirus per Cheryl. Cheryl also spoke with the school nurse and she could not confirm a large group of students sick from one source. Cheryl could not

determine any evidence of a food borne illness and could not verify multiple illnesses. Julie also inspected UNO's and no employees were sick during that time, a policy is in place and the restaurant was very clean, some new equipment and no issues with rodents.

Health Agent Update: Julie VanArsdalen – reviewed her inspections. Star Dumpling will be re-inspected when building and fire are satisfied. 3 Overlook was sent a trash and unregistered motor vehicle letter, 7 Allstead Path may need additional time due to health issues, A letter was sent to 185 Millbury Ave, 19 main street had a flooded basement – must dehydrate and test for mold, met with property owner.

Local Upgrade/Variance: None

CMRPHA Update: Phil Leger explained that the current recreational camp regulations will stay in place this year. Christian's Law is in effect for this beach season and involves a swim and fit test requirement and life jackets must be provided.

New/Old Business:

Vape Shop: Judy mentioned a company called and wants to open a vape shop. Ron stated some issue came up at the selectmen's meeting regarding a controversy with the proposed location and an auto shop as well. Vape shops are allowed with our current regulation.

Clothing Bins – review permitting progress.

Fee Schedule: Reviewed Phil's recommendations. Must also review with Selectman for final approval. Will have an extra meeting on 4-26 to review fees only.

Tobacco Regulations: Tabled – Jim mentioned T21 and feels the board should consider adopting this. Vape Shops to be reviewed at a future meeting.


Farmer's Markets – discuss at a future meeting.

Ron will contact Dorenzo's in regards to a crash vehicle for prom.
