**Call to Order:** Ron Marlborough called to order the meeting of the Millbury Board of Health at 4:10PM on November 14, 2018 in Millbury Town Hall Board of Health Office.

**Approve Minutes:** MOTION: Jim Morin made a motion to accept the minutes of the meeting. Seconded by Ron Marlborough. All approved.

**Office Update:** Judy mentioned Upper Blackstone policy on Tight Tanks and the need for a new file cabinet. Ron stated to ask Brian to look at the schools.

**Variance/Local Upgrades:** None

**Tobacco Coalition:** Eric Jack explained his position on the Tobacco Violation at Riverside and explained that the language in the regulation was changed to avoid confusion only.

**Public Health Nurse Update:** Judy stated that Cheryl is hosting the Regional Meeting at ASA Waters Mansion on 12/6 from 9:00 to 11:00 AM and all are welcome to attend. Also, she has used all of the Flu Vaccine.

**Health Agent Update:** Julie stated that she will be on the Alcohol Inspections with the Fire Chief and Building Inspector on 12/4 and 12/6. She has also scheduled Truck Inspections at the sewer plant. A letter was sent to Rhodes to Recovery to redo the roof. She would like to have a crew of people to assist with an inspection as food issues are still a concern. The food card incident was not reported to DPH. Julie updated Erica. Ron wants to make sure that they

have food for Thanksgiving. Julie will email Cheryl to accompany them on the inspection 11/20 at 10:00 AM. Julie asked about billing the Town for Truck Inspections performed on a Saturday

and extra tobacco inspections. Ron will look into that. Cigarette Machine at Sunrise is against our regulations. Ron will talk to Sunrise.

**Karyn Clark:** Karyn stated that she has been reviewing Millbury's current by-law for marijuana and she is working with DJ Wilson in regards to writing a regulation for the Board of Health.

**T21 Tobacco Regulation:** Karyn Clark explained that the State has moved to T21 with a Grandfathering clause and the Board may vote to not grandfather current 18 year olds an move to only 21 for Tobacco/Nicotine products. Karyn presented an amended regulation to include T21 and an additional amendment to include Pharma restrictions. The board agreed on T21 only.

**MOTION:** Jim Morin made a motion to amend the current Tobacco Regulation to include T21 effective 12/31/18.

Seconded by Ron Marlborough.

New Regulations along with a letter will be sent to all Tobacco retailers.


**CRMPHA Update:** The Board reviewed the print out provided by CRMPHA.

**Motion to Adjourn at 5:30 PM:** Jim Morin made a motion to Adjourn


