NEW BUSINESS - Contract Negotiations

The contract with Charter Communications expires December 1, 2018. The contract with Verizon expires September 8, 2018.

OLD BUSINESS - Warrant Article

Public Access money that we receive is grants from the cable companies. All along we have been doing it the right way by putting it in a separate account and using it for what we need it for and retaining the balance in a special account dedicated for public access.

The state found that some towns are not doing that and are putting the money in the general fund. There is a new MGL Chapter 44 Section 53F ¾ stating that you need to establish a special cable fund or an enterprise fund, it's the town's choice, to preserve this money that you get in and earmark it for local access (purchasing equipment, personnel, etc.).

We have been doing it this way all along; we just need to get it approved at town meeting. Chairman DiCicco reiterated that the funds we receive are grant money that comes from Verizon and Charter, and that is a very important word – grant money – because the grant is given to the town specifically for public access and cable use and this is what we are trying to protect. We keep the principal and the town keeps the interest.

The Chairman read the warrant article in to the record (attached).
