Mr. Spain explained for the Blackstone Valley Tech article the town meeting vote cannot vote to indefinitely postpone because that would show no action and we would have to fund it through the budget but they needs to indefinitely postpone with the words so as to express the disapproval of amount of debt authorized by the district as set forth in the article. Selectman Borowski asked why we can't just request a straight no vote. After much discussion, Attorney Eichman explained the reasoning behind the motion. We need to explain that Millbury does not want to take part in the expansion, which was the will of the people at the ballot. Chairman King thought we should go with the motion written by the attorney for Mr. Spain.

The Board attended the Annual Town Meeting. Mr. Spain, Selectman Ashmankas and Selectman Borowski spoke in favor of defeating Article 13, the BVT article. Mr. Spain also spoke in favor of taking Brierly Pond Dam by eminent domain to be able to repair it; it did not pass. All other Articles passed with the Finance Committee/Planning Board recommendations.
