Temporary Moratorium on Recreational Marijuana- Selectman Krumsiek read a letter from The Planning Board who is putting an article on the warrant for a moratorium on recreational marijuana; there will be a public hearing on January 3, 2016 5:30 pm at the High School for the zoning by law change.

Selectman Despres has an issue with the article in their book does not match the article that was handed out at the Planning Board meeting last night; the current by-law states that the sale of marijuana is not permitted in the town; he does not understand why the town needs this when we have a bylaw that already covers this. The by-law that we have covers medical marijuana only. Terry Burke Dotson spoke said that she and Anna Lewandowski put this together to request a moratorium. Ms. Lewandowski clarified stating that the article that they submitted to the Planning Board was taken directly from the Town of Ashland. The Planning Board decided to put one on the warrant so that the citizens did not have to get the required signatures.

Motion to vote to put a temporary moratorium article on the Special Town Meeting warrant made by Selectman Despres, seconded by Selectman Krumsiek.

Chairman King asked the chief about no parking on Howe Ave due to the construction and trucks. Chief Desorcy researched the parking in the Howe Ave area back to 1986; there is some no parking areas already that are not signed. He would suggest no parking only on Lincoln Ave Ext. but he does not want to punish the residents on the street; if it is no parking then it would be no parking. Howe Ave itself does not have an issue with parking but if you want the whole stretch you can do that too.

Selectman Krumsiek would like no parking from the old rail road tracks to Lincoln Ave ext. The board asked the Chief to draw up a schematic with no parking on the westerly side of Howe Ave and some area of Lincoln Ave Ext.

Selectman Cristo asked if we know what conditions were set for the methadone clinic?

Selectman Adams asked about the Chapter 90 money being used next fiscal year.

Mr. Plante met with Mr. Sannicandro and interim Town Planner Chris Ryan regarding obtaining the kennel license on Sycamore Street who told Mr. Sannicandro that he had to go before the Board of Appeals.
