Previous Minutes: December 6, 2011

Motion made by Selectman Stowell to approve the minutes, seconded by Selectman Schold. Motion carried unanimously.

<u>One Day Liquor License</u>-Currier & Chives at Asa Waters on December 16, 2011 Motion to approve the license made by Selectman Schold, seconded by Selectman King. Motion carried unanimously.

<u>Laurie Connors-Town Planner</u>: She is here to have Cronin Brooks Heights go through the acceptance process for remaining three roadways. The issues were the streetlights and concern for the sinkhole. It has been well over a year and it has set and has not had any problems. There is some open space land that will be conveyed to the conservation commission and they voted to accept that land. The Selectmen have to allow the conservation commission to accept it. It will make the areas more accessible for the DPW. The new owner, Russell DeDoming has really bailed us out and did a quality job.

Motion made by Selectman Stowell to authorize the Conservation Commission to accept the gift of land described in the foregoing deed, for conservation purposes pursuant to MA General Laws, Chapter 40, Section 8C, granted from Cronin Brook Heights LLC. The land is acquired for conservation and passive recreation purposes, and shall be subject to Article 97 of the Amendments to the Massachusetts Constitution, seconded by Selectman King. Motion carried unanimously.

Motion made by Selectman Stowell to begin the process of laying out Cronin Brook Way, a way situated northwest of Braney Road located in the southeastern section of the Town of Millbury, in the County of Worcester. Said roadway is shown as Cronin Brook Way on a plan entitled "Roadway Acceptance Plan, Cronin Brook Way & Braney Road, Millbury, Massachusetts" prepared by S.E.C. & Associates, Inc., dated October 13, 2010, last revised December 14, 2010. The roadway will be conveyed subject to and with the benefit of all easements shown on the plan, seconded by Selectman Ashmankas. Motion carried unanimously.

Motion made by Selectman Stowell to begin the process of laying out Diana Hill Drive, a way situated north of Cronin Brook Way located in the southeastern section of the Town of Millbury, in the County of Worcester. Said roadway is shown as Diana Hill Drive on a plan entitled "Roadway Acceptance Plan, Diana Hill Drive and Taft Circle, Millbury, Massachusetts" prepared by S.E.C. & Associates, Inc., dated October 13, 2010, last revised December 14, 2010.

The roadway will be conveyed subject to and with the benefit of all easements shown on the plan seconded by Selectman Schold.

Motion carried unanimously.

Motion made by Selectman Stowell to begin the process of laying out Taft Circle, a way situated northwest of Diana Hill Drive located in the southeastern section of the Town of Millbury, in the County of Worcester. Said roadway is shown as Taft Circle on a plan entitled "Roadway Acceptance Plan, Diana Hill Drive and Taft Circle, Millbury, Massachusetts" prepared by S.E.C. & Associates, Inc., dated October 13, 2010, last revised December 14, 2010. The roadway will be conveyed subject to and with the benefit of all easements shown on the plan, seconded by Selectman King.

Motion carried unanimously.

Motion made by Selectman Stowell to forward the petition to accept the proposed layout of Cronin Brook Way, Diana Hill Drive and Taft Circle to the Millbury Planning Board for comment as to whether the roadways are ready for acceptance, seconded by Selectman King. Motion carried unanimously.

Motion made by Selectman Stowell to schedule a visit to view Cronin Brook Way, Diana Hill Drive and Taft Circle on January 8, 2012. The public meeting on the proposed acceptance of these roadways will occur on January 25, 2012, seconded by Selectman King. Motion carried unanimously.

Motion made by Selectman Stowell to amend motion of site visit to January 7, 2012 at 10 am and public hearing January 24, 2012, seconded by Selectman King. Motion carried unanimously.

Charles F. Minney Post-Public Hearing-Change of Manager

Selectman Schold read the notice into record.

Robert Roy appeared for the VFW. They have made some changes to better the establishment. Motion to change the manager made by Selectman King, seconded by Selectman Stowell. Motion carried 4-0-1 (Selectman Schold abstained).

Town Auditors-Roselli Clark Associates: Tony Roselli spoke about the audit of the Town. In this town things are done well. All the things mentioned in last year's management letter have been fixed. The town's bond rating increased because of the levels the town has maintained. This is a great reward for the town. See attached management letter*.

With the economy going down, fraud seems to be going up. Finance Director is already on top of this.

Chairman Plante would like to compliment Brian, Denise, Paula and the Manager.

Paul DiCicco wanted to give compliments to the financial team as a taxpayer. He spoke regarding the **Transfer Station Privatization Committee**. *see attached comments. Selectman Stowell said that they accomplished a lot in a short amount of time. They want to revisit the suggestions in 6 months and 1 year to follow through. Laurie Connors found a lot of grant money as part of our green community and other grants that we can apply for.

Mill Towne Tavern- Acting Chief Moore spoke regarding his concerns with the amount of calls to the police of over intoxicated patrons coming from the Mill Towne Tavern. Selectman Stowell asked if this compares to the previous establishment. There is no comparison to the last. Chairman Plante mentioned that at least they are calling the police when there are problems happening. Acting Chief Moore thought maybe they could call before the altercations start. Pam Perkins spoke regarding the staff; they do not want to put up with this type of issues. They want to work with the police. All bartenders are tips certified. Selectman King suggested they talk to Acting Chief Moore to get some help. Chairman Plante told them to keep up the good work.
