Re: Public Meeting held Thursday, May 5, 2016, at the Veterans Memorial Building, Room 206, to vote/approve amended CPC Article(s) as follows:

Mr. Aspinwall discussed the application for the Veterans' Memorial Building Historic Door Replacement and Refurbishment Project. Quotations from New England School Services, Inc. were presented.

At the regularly scheduled meeting of the Community Preservation Committee on May 5, 2016, on a motion made by Mr. John Northgraves, seconded by Mr. McCaffrey, it was voted (5-1) in favor, with Mr. Normandin opposed, to appropriate \$25,750.00 for doors (Quote Number K1043) and \$3,592.00 (Quote Number K1045) for hardware, a total of \$29,342.00, for the Main Street facing doors from the Community Preservation Budgeted Reserve.

At the regularly scheduled meeting of the Community Preservation Committee on May 5, 2016, on a motion made by Mr. John Northgraves, seconded by Mr. Maltinsky, it was voted unanimously (6-0) to appropriate \$13,400.00 for two side doors (Quote Number K1044) and \$2,132.00 (Quote Number K1046) for hardware, a total of \$15,532.00, from the Community Preservation Budgeted Reserve.

The Community Preservation Committee recommends approval in the total amount of \$44,874.00 from the Community Preservation Budgeted Reserve for the above article (Article 32) for the Veterans' Memorial Building Historic Door Replacement and Refurbishment Project at the Town Meeting to be held on Monday, May 9, 2016.
