Ms. Lannon moved and Ms. LeBlanc seconded that the Millis Board of Health meeting of November 7, 2017 be opened at 7:00 p.m. It was unanimously voted to open the meeting.

7:15 Environmental Health Permit Application for new Clyde Brown School

Kathy Lannon made a motion to reopen the New Clyde Brown School Environmental Health Permit Application discussion. Ms. Hilton seconded the motion and it was voted unanimously to reopen the discussion. Responses to the Board's outstanding concerns were reviewed from a letter to the Board from Tappe Architects dated 10/31/2017 as well as the Draft Environmental Health Permit drawn up by the Board's engineering consultant, Melissa Recos of Beta Engineering. Updated plans including information concerning the roof drain system were also provided.

A condition concerning the installation and maintenance of the 3,500 gallon grease trap was reviewed and updated with BOH maintenance requirements.

Conditions that final stormwater components design and supplemental information must be provided and approved by the BOH prior to installation and that final stormwater infiltration system layouts with isolator rows shall be submitted for review and approval prior to installation were added.

A motion was made by Ms. Lannon and seconded by Ms. LeBlanc that the final permit would be approved with the above additions included. The vote was unanimous.

On a motion made by Ms. Lannon and seconded by Ms. LeBlanc , it was unanimously voted to grant the variance requested from Section XII.2.a, of the "Millis Board of Health, Public and Environmental Health Review Regulations" to allow a decrease in the rate and volume of stormwater runoff from the site. The proposed variance is considered non-detrimental because current environmental standards encourage on-site stormwater recharge.

On a motion made by Ms. Lannon and seconded by Ms. LeBlanc, it was unanimously voted to grant the variance request requested from Section XIII.2.a, of the "Millis Board of Health, Public and Environmental Health Review Regulations" which prohibits excavation to within 7.5 feet of maximum groundwater elevation to provide for potential subsurface sewage disposal systems. The proposed reduced groundwater separation is considered non-detrimental because, as noted into the record, it is proposed to service the new developmental with public sewer.

Daniel Merrikin, P.E. Merrikin Engineering, LLP asked that the application hearing be postponed. He will notify us when they are ready to continue hearing.

8:00 PM – Budabing's 50's Café

Barbara Thissell inspected Budabing's on 10/25/2017 and though no critical violations were found, she followed up with a letter to Ed Harutyunyan, the owner, concerning resolution of the findings she had made. Prior to this meeting all of the deficiencies were resolved to Ms. Thissell's satisfaction so the hearing was cancelled.

Recognition of Outgoing Director

Tonight was the final BOH meeting for Barbara Thissell, BOH Director. The Board of Health thanked Ms. Thissell for her exemplary work as Millis BOH director. They cited their appreciation for her strong technical skills, her organizational abilities, flexibility, and customer service orientation.

Thissell submitted a document entitled "Health Department – Protocol" that outlines duties for the BOH administrative assistant. This is particularly helpful as all current administrative assistants are temporary employees. She also provided an outline of BOH regulations for the next BOH director.

Ms. Lannon moved and Ms. LeBlanc seconded that the Board of Health meeting of November 7, 2017 be closed at 9:40 p.m. The Board voted unanimously to close the meeting.
