- Decided not to take the offer of the copier from St. Paul's.
- Carol looked into new cabinets and pictures. A cabinet with doors would cost approximately \$200.00, pictures from \$16.99 to 39.99 at Home Goods. She will check on 6' cabinets with and without glass doors. We have \$500.00 in our budget for these improvements we will ask the Friends for their assistance in the purchase.
- Helen said that Thora Smith might be willing to come and give some ideas at the next meeting
- Patty could not attend the HESSCO meeting last week she would like to suggest a cold plate menu instead of some of the food offerings.

## **New Business**

- The Board has heard complaints that Patty is not visible enough at the center Mary suggests that Patty should ask for 10 more hours per week. She currently has 20 hours/week and 5 hrs- 4 days/week with the Supportive Day Program. There are currently 6 people in Supportive Day which is a self-supporting program. Patty currently has an applicant to assist with this program she is waiting for results of CORI report.
- The committee will attend the Fin-Com meeting on 1/25 @ 8:15 to request increase of Patty's hours from 20 to 30 hours per week.
- Patty will research other director's hours in the area.
- St. Paul's Feasibility Study discussed possibility of using St. Paul's if town moves to purchase? Helen advised that a P&S has been signed by another party for the property.
- It was noted that town support of seniors lacks terribly that according to recent town report we have more seniors than school aged children in Millis.
