488 surveys were sent out with 44% received back – mostly with positive feed back

Does HESSCO services allow people to continue to live independently? Large % was Yes

66% said that lunch was their main meal of the day

40% said that the meals driver was the only person they saw on a regular basis

95% said that they would recommend HESSCO to other people

Currently two State Senators are working on transportation needs

- Carol visited most meals recipients this past month and gave out Girl Scout cookies to all
- She will bring COA newsletters to new households at the Senior Housing Complex
