#### GIRL SCOUT TROOP 74941 COMMUNITY GARDEN PROPOSAL

The Girl Scouts presented their proposal for a Community Garden in town. They propose to establish initial demonstration plots, approximately 15' x 30', to work with schools and other scout troops, growing vegetables; many of which could be donated to the food pantry. Eventually they would hope to open it up to more general use by reaching out to the community to establish a governing board and long-term sustainability. According to the girls, they spoke to Ms. Laura Tangerini and she has offered to mentor them. The Girl Scouts have two years to complete the project for their Silver Award.

The Girl Scouts are requesting location ideas from the Commission to use a portion of a Conservation Commission parcel for the community garden. Dr. Lederer stated that he would speak to the Tangerini's to discuss possible locations and get back to the Girl Scouts. The Commission was in favor of the Community Garden proposal and thanked the Girl Scouts for their presentation.

#### **NEW BUSINESS:**

Auburn Road John & Martha Kerns Informal Discussion

Mr. Wayne Carlson presented a sketch plan of the Kerns' property on Auburn Road. The wetlands were flagged on the plan, Mr. Carlson said, with the line being defined by soil and vegetation. Mr. Carlson stated that a single family home construction is being considered, however, the entire area is within the 100-foot buffer zone and 50-foot do not disturb zone. Mr. Chisholm stated that a Notice of Intent filing would be required. The Commission would consider mitigation for the project, but that would be further discussed during the Notice of Intent hearing process.

### 6 Myrtle Street Horse Farm Informal Discussion

Mr. Carlson stated that the property is 45 acres and potential buyers of the property are considering constructing a commercial horse farm. Zoning issues were discussed, as well as floodplain and wetland issues. Mr. Carlson stated that 46 horses would be housed on the farm. Mr. Carlson said that the sale of the property "has not gone through yet." Mr. Carlson will flag the wetlands and file an Abbreviated Notice of Resource Area Delineation.

An email, dated January 21, 2014, and map were received from DEP. An area of possible wetlands filling violations was discussed. The Commission will provide DEP with the address of the location in question.
