REQUEST FOR DETERMINATION OF APPLICABILITY, PUBLIC HEARING EXISTING EVERSOURCE RIGHT-OF-WAY (ROW) EVERSOURCE

The public hearing was opened at 7:51 p.m. by Dr. Lederer, Chair.

Mr. Mark Bergeron of Epsilon Associates, representing the applicant, presented the application and plans. The application is for a subsurface geotechnical boring program located in Eversource's existing right-of-way ("ROW"), (#325-#344), in Millis. There are five locations in Millis, he said. Mr. Bergeron stated that the proposed borings are needed to gather necessary subsurface data for the planning and design of future transmission towers to be constructed on the ROW. The work is temporary and will be conducted in a manner to limit Bordering Vegetated Wetland alteration. A Notice of Intent will be filed at a later date for future work/construction of the towers.

On a motion made by Ms. Rich, seconded by Ms. Gavin, it was voted unanimously at 8:09 p.m. to close the public hearing.

On a motion made by Ms. Rich, seconded by Mr. Tangerini, it was voted unanimously to approve a Negative 3 Determination of Applicability, with Special Conditions as listed in the letter dated, September 17, 2018, for the Eversource Geotechnical Boring Program.

<u>DEP FILE#CE225-0403, AMENDMENT TO ORDER OF CONDITIONS, PUBLIC HEARING – 39 MAIN STREET</u> BEAU GRASSIA

The public hearing was opened at 8:11 p.m. by Dr. Lederer, Chair.

The Commission reviewed the Request for Amendment letter, dated September 17, 2018, prepared by Joyce Hastings of GLM Engineering. Mr. Grassia was instructed to file for an amendment when unauthorized work was done which was not authorized/permitted in his Order of Conditions. The Commission reviewed the approved plan and as-built plan submitted.

According to Mr. Grassia, he "took truckloads of fill out and did not bring any in." He apologized to the Commission and stated that he "thought" he "was doing something right." Ms. Rich stated, in her opinion, Mr. Grassia "did something entirely different," which was not permitted and she finds it "astounding." Mr. Grassia was told that he should have come to the Commission beforehand.

The Commission requested that Mr. Grassia contact his engineer to provide prior elevations before the work was done and fill removed. The Commission also wants the plan revised to show elevations.

As part of the amendment request, Mr. Grassia proposed the construction of a 13' x 15' shed in the rear yard, which will be supported by sonotubes. Mr. Lee stated that Mr. Grassia would have to prove "extreme hardship" to allow a structure within the fifty foot buffer zone.

On a motion made by Ms. Rich, seconded by Mr. Lee, it was voted unanimously at 8:30 p.m. to continue the public hearing to Monday, October 29, 2018, 7:30pm.
