The Commission was contacted by Ms. Katie Potrzuski of SKM Title & Closing Services, P.C. It appears that the Certificate of Compliance issued in May of 2011 was never recorded at the Registry of Deeds. Ms. Potrzuski requested that the Commission sign another signature page so she could record the document. According to Ms. Potrzuski via email dated February 5, 2013, the owners of 7 Ryan Road (John & Alice Croatti) are selling their home and the old Order of Conditions is still on the title.

Signage
