The public hearing was opened at 7:30 p.m. with notice being read by Dr. Lederer, Chair.

Mr. Wayne Carlson, representing the applicant, presented the application and plans for the proposed single family home construction within the buffer zone of the Bordering Vegetated Wetland. Mr. Carlson stated that Mr. & Mrs. Kerns will be selling the lot and not actually doing the building, however, they are filing for the permit. Most of the lot is wetland, Mr. Carlson said. Mr. Carlson stated that he has flagged the wetlands, based not only on vegetation, but on soils as well. Proposed stormwater drainage calculations and floodplain issues were discussed.

A site visit was scheduled for Friday, May 30, 2014, at 6:30 p.m.

On a motion made by Ms. Rich, seconded by Mr. Chisholm, it was voted unanimously at 7:50 p.m. to continue the public hearing to Monday, June 23, 2014, 7:30 p.m.

The public hearing continuation was opened at 7:50 p.m. by Dr. Lederer, Chair.

Mr. Merrikin, representing the applicant, 400 Old Post LLC, stated that they have completed their responses and revisions and will submit everything on Tuesday.

The Commission discussed a letter from Kimberly Burlingame, Environmental Scientist, dated May 19, 2014 and a Vernal Pool Inspection letter dated April 28, 2014, from Goddard Consulting. Mr. Merrikin's consultant from Goddard Consulting "concluded there was no vernal pool species" in the isolated vegetated wetland on the site. He stated that it was their understanding that the Commission's consultant "reached a similar conclusion." Ms. Thissell stated that unfortunately, the inspections were done a bit too late in the season.

Mr. Merrikin summarized the changes to the swale at Acorn Street which will be widened to accommodate the 100-year storm. There are no proposed design modifications in the buffer zone, he said.

On a motion made by Ms. Krinsky, seconded by Mr. Lee, it was voted unanimously at 8:00 p.m. to continue the public hearing to Monday, June 23, 2014, 8:00 p.m.
