211 PLEASANT ST. SEPTIC REPAIR INFORMAL DISCUSSION

Ms. Thissell of the Board of Health notified the Commission (via email dated 9/3/2015) that she was reviewing a proposed septic repair at 211 Pleasant Street. The design engineer had expressed concern regarding wetlands in the vicinity of the property. Mr. Vey of BIG excavation, stated that the septic replacement is necessary to sell the property. The Commission reviewed the maps of the septic repair location and determined that there were no wetland issues and they may proceed with the proposed septic repair work.

<u>DEP FILE #CE225-0390, NOTICE OF INTENT, PUBLIC HEARING, OFF MAIN ST., SOLAR ARRAY</u>

The public hearing was opened at 7:32 p.m. with notice being read by Dr. Lederer, Chair.

Mr. Feeney of Beals & Thomas presented the application and plans. He stated that the application is being filed on behalf of the applicant, Clean Energy Collaborative. The filing is for proposed work within the Resource Areas of Bordering Vegetated Wetlands, Land under Water Bodies and Waterways, Riverfront Area, Bordering Land Subject to Flooding and the Buffer Zone of BVW. The proposed development includes the installation of a ground-mounted solar photovoltaic solar array and related appurtenances, including a security fence and gravel access road off Main Street. Mr. Feeney discussed the existing conditions of the site stating that the site is currently undeveloped, wooded land which contains wetlands. He said that five acres would be solar arrays and another acre outside would be for stormwater basins and the access road. Mr. Feeney stated that a significant portion of work associated with the solar array installation will take place outside of the jurisdictional buffer zones and resource areas. Work proposed within the 100-foot buffer zone to Bordering Vegetated Wetlands, Inland

Bank, and Bordering Land Subject to Flooding includes clearing of vegetation, installation of solar array panels, installation of the security fence, construction of a gravel access road, pollarding, and impact mitigation where two stormwater basins are proposed. Additionally, he said, pollarding (of 6-8' tree height) is anticipated to take place within a portion of the BW and BLSF in order to avoid shading impacts to the proposed array. Mr. Feeney stated that the wetlands were delineated during June and July 2015 by Russell Waldron of Applied Ecological Sciences. Mr. Feeney stated that a wildlife study will be done by Goddard Consulting.

There was discussion regarding the plans. Mr. Lee suggested mitigating by moving some of the solar panels outside of the buffer zone. Mr. Feeney stated that the panels are placed where they are due to "shading issues." Mr. Lee said that requesting a waiver is meant for instances of hardship; where this is not the case with this application. In his opinion, he would rather some of the panels be moved, Mr. Lee stated. Mr. Chisholm asked if the Federal communication line along the railroad bed was still active. Mr. Harkey did not know the answer to this question. Mr. Chisholm stated that he wants the applicant to "find where it is" before any work begins. He also requested that the applicant be certain no sewer lines run down Cedar Street. Mr. Chisholm stated that construction information is missing from the plans. He wanted "a few cross sections" shown. The cross sections should include "Existing Conditions," "Final Conditions," and arrays shown to scale, he said. Mr. Chisholm also requested that sheet C3.1 be revised to make the "General Notes" section site specific. The Commission wants construction sequencing and erosion controls proposed shown; also the number of swales proposed. They also want more details on the proposed pollarding – what type of trees, etc. Mr. Chisholm stated that he recommends NOT starting construction/bull-dozing in the Spring; "it will be a quagmire out there," he said.

Mr. Chorey expressed objections to the on-site Intermittent Stream labelling when GIS mapping classifies it as Perennial. Mr. Feeney will review this further. Mr. Chorey wants to know how the surfaces will be stabilized to bind the soil.

Stormwater Management was discussed. Mr. Feeney stated that a wildflower seed mix would be used and mowed once a year "to slow any runoff down." They are not proposing to change the natural flow patterns. Mr. Feeney stated that they would add soils to the drainage area plans. Dr. Lederer referenced the email from DEP regarding the file number assignment. DEP had noted that Stormwater Management information for post-development hydrology for the project needed to be provided. Mr. Feeney stated that he spoke to DEP and there was a clerical error where their copy of the Notice of Intent was missing that information. He said that he had since emailed the information to DEP for review.

Dr. Lederer stated that the Commission, at the applicant's expense, would like to have the application and plans reviewed by their peer consultant at Nover-Armstrong Associates, Inc. The applicant was amenable to the request. Due to the various revisions to the plan and supplemental information to be provided, the Commission will continue the public hearing.

Dr. Lederer stated that as long as a fire permit is issued from the Fire Department and the Police Department is informed, camping and campfires in the fire pit are allowed.

The Commission thanked Ms. Golden for doing such a wonderful job with her project.

3 IRON WOOD LANE PROPOSED SEPTIC REPLACEMENT

Ms. Thissell of the Board of Health emailed the Commission regarding a proposed septic replacement. The Commission reviewed the information and there appeared to be no wetland issues with the project.
