The meeting was called to order at 7:34 p.m. by Mr. Maltinsky, Vice Chair.

Church of Christ Steeple & Clock Repairs Funding Request

Mr. Bullion presented the application. He provided a history of the Church of Christ, which was founded in 1714. Mr. Bullion stated that for the past 161 years, the church building has served Millis and Medway, not only as a center of worship, but as a meeting place for many town activities; Boy and Girl Scouts, Millis Food Pantry, etc. While some of these groups, he said, pay modest fees for the use of the building, most use the church at no charge at all. The Church of Christ is a completely self-sustaining organization, Mr. Bullion said, where funding comes 100 percent from donations and rental income. For the past several years, he stated, the church has faced the challenges of declining membership, reduced rental income, and an increase in capital and maintenance expenses. Mr. Bullion stated that the purpose of this application request is for funding to repair the clock, which has not worked in over two years, and repairs to stop the steeple from leaking.

Mr. Bullion stated they are requesting \$80,000.00 in CPC funds and he discussed the task and cost breakdowns. Mr. Maltinksy explained the CPC approval process and procedures for cost estimates, bids, and prevailing wage. He requested more definition/detail for the "Interior repairs/upgrade" category. Mr. Bullion will provide more detail; specifically on the cat walk area.

Mr. Howie stated that they have already received two out of three estimates requested for the work. These estimates are from firms specializing in steeple work, he said. Mr. Maltinksy explained that three estimates are required before the application could be considered, and the lowest bid is awarded the contract.

The CPC members were in agreement that the Church does contribute to the community and this is a worthy project; their request does fit the criteria.

Mr. Bullion will work on getting the third estimate and detailing the specifications as requested and will attend a later meeting. They may attend the January 5, 2012, televised meeting for their presentation if they have their information put together by that date.

Recreation & Wildlife Application (File# 2010-007) Land for Open Space

Mr. Maltinsky updated the Committee of the status of the 21E Environmental Assessment of the Braun property. Mr. Aspinwall received an estimate from PCA Landscape in the amount of \$320.00 to cut a path from the road to the river. This is needed in order for the test pits to be dug to continue with the environmental assessment process.

On a motion made by Mr. Maltinsky, seconded by Ms. Rich, it was voted unanimously to authorize \$320.00 of funds from the CPC Expenses account for payment to PCA Landscape for cutting of the path.

Niagara Firehouse – Phase II Funding Request Nathan Maltinsky

Mr. Maltinsky had presented a Funding Request Application and letter, dated September 8, 2011, for Phase II restorations in the amount of \$120,000.00. The application was approved.

On a motion made by Ms. Rich, seconded by Mr. Normandin, it was voted unanimously to amend Article #16, to appropriate and raise by transfer the sum of \$120,000.00 for continuation of the Niagara Fire House Restoration Project, of which \$10,000.00 shall be transferred from the Community Preservation Fund Historic Resources Reserve, \$40,000.00 shall be transferred from the Community Preservation Fund Budgeted Reserve, and \$70,000.00 from Undesignated Fund Balance.

The Community Preservation Committee **recommends** approval of the article at the Town Meeting to be held on November 7, 2011.

Dewey Property - Update 5.3 Acre Parcel
