Warrant Item Reconsiderations/Recommendations:

Article #10 – Police Cruisers:

\$64,110.00

Chief McGowan:

The Ford Crown Victoria will be discontinued; the last model year will be 2011. The MHQ rep cannot guarantee availability if the second cruiser is not considered until the Spring 2011 Town Meeting. MHQ has 300 in stock and another 200 on order. Two police officers share each vehicle in the fleet averaging twenty four thousand miles per year. The extra cruiser would extend the life of the fleet. The Police Department would not request additional vehicles until FY13 if the second cruiser is recommended/approved. The repair and supply expenses are predictable with the Crown Victorias. First year vehicles have a tendency to have issues that need to be ironed out. The new Ford Interceptor will not be available until January 2012.

Peter Jurmain made a motion to reconsider Article #10, Susan Vecchi seconded. Vote: 7/1, motion carries.

Peter Jurmain made a motion to recommend two cruisers for Article #10 in the amount of \$64,110.00, Susan Vecchi seconded, further discussion: \$160,000.00 of Free Cash could be used for warrant articles, \$300,000.00 has been earmarked for recurring articles for the Spring Town Meeting. Rick Manburg feels the second cruiser is not a true need at this time. The Police Department would order one cruiser immediately and defer the purchase of the second cruiser as long as possible for warranty reasons. Vote: 7/1, motion carries.

# Charles Aspinwall:

In FY10 the Town spent approximately \$4,500.00 in beaver dam repairs; so far in FY11 the Town has already spent \$13,670.00. The beaver guards seem to work so far, if they fail the DPW would be requesting the purchase of a truck at the Spring Town Meeting instead of hiring equipment to free the culverts blocked by the dams. An estimated cost of the truck is between \$30,000.00 and \$40,000.00. The Orchard Street culvert may be too large to build a beaver guard. The cost of the beaver guards are absorbed in the DPW budget, there is zero budgeted in FY11 for beaver guards.
