THOMAS ROCHE INFORMAL DISCUSSON CONCEPTUAL PLAN – SPRING ST.

Mr. Roche had requested an informal discussion; however he was unable to attend the meeting. He requested, via email, being re-scheduled to the December 13th meeting.

SOUTHEND FARM SUBDIVISION MINOR MODIFICATION REQUEST SUBDRAIN SYSTEM IN BEECH ST. DAN MERRIKIN

Mr. Merrikin presented a letter, dated October 26, 2011, and a one page plan entitled, "Southend Farm Minor Modification Plan of Land in Millis, MA," dated October 26, 2011. Mr. Merrikin explained that the original design called for a subdrain to be installed along the westerly side of Beech Street. However, he said, in completing the septic system testing and designs for the latest batch of lot developments, they were unable to find a septic location that could maintain the requisite 50-foot setback to the subdrain for Lot 24 due to shallow ledge deposits. Mr. Merrikin stated that they are requesting a minor modification to allow the subdrain from stations 21+00 to 22+50, as shown on the plan, to be abandoned as it is not necessary. An alternative option, he said, is to allow the subdrain to be abandoned with a replacement subdrain to be installed near the centerline of the roadway as shown on the plan. In Mr. Merrikin's opinion, he said, they prefer to abandon that stretch of subdrain.

Ms. Thissell summarized her review letter, dated November 15, 2011. Ms. Thissell stated that she does agree with Mr. Merrikin's request to allow the abandonment of the subdrain as she does not believe the subdrain is warranted after her review of the existing groundwater information. She stated she recommends approval of his request as a field change as the subdrain was not needed initially.
