The meeting was called to order at 7:30 p.m. by Mr. Cantoreggi, Chair.

SKATE PARK – INFORMAL DISCUSSION JOHN & DECLAN CORCORAN

The Board met with Mr. John Corcoran and his son, Declan. They presented information on a proposed Skate Park in a section of the parking lot in an area of Town-owned property behind the Millis Public Library. Mr. Corcoran stated that they are looking for a safe, clean, "fun area" for local children to use skateboards, BMX bikes, scooters, remote control cars, etc. The target age group would be Millis residents under the age of 21.

The proposal would use twenty of the parking spaces at the rear of the lot, he said. Insurance is roughly \$2,000.00 per year which could be raised via various fundraisers, he suggested. Fundraising efforts could also be used for upkeep/maintenance of the area. According to Declan, a Skateboard Club at school could help keep the area clean as well.

Mr. Corcoran will follow-up with Mr. McKay to gather more information on the underground stormwater system in the area. Mr. Corcoran will also contact the Board of Selectmen to discuss/request the use of the land, etc.

The Planning Board was in favor of the proposal as presented; pending any permitting requirements.

UPDATE ON CONSTRUCTION PROJECTS

Mr. Cantoreggi provided an update on the Dover Road Residences assisted living project. He stated that the owners are working with the construction company on cost effectiveness to minimize the expense of BETA's review/site visits. They are moving forward.

Mr. McKay provided an update on the Glen Ellen/Toll Brothers senior residential community development. The first twenty-two units in Phase I have already sold out and the applicants will be approaching the Town to proceed with Phase II construction. They are scheduled to pass papers on the first home in September, he said.

On a motion made by Mr. Cantoreggi, seconded by Mr. Nichols, the FY 20 Planning Board Budget totaling \$30,641.60 was unanimously approved as prepared.

On a motion made by Mr. Cantoreggi, seconded by Ms. Riley, it was voted unanimously to approve the regular session meeting minutes from December 11, 2018, as written.
