• <u>April Meeting</u>

Bob Clark suggested that the Conservation Commission put together a program for 2010.

The Commission will revisit the Steep Slopes Ordinance. At the same time as discussing this proposed ordinance, Cristina Ashjian suggested that the Commission may want to invite the Town Planner in order to discuss a visual inventory.

Phosphates/Nitrates/Chemicals Prevention in Lakes/Ponds/Rivers, Streams

On March 3, 2010, there will be a workshop at the Laconia Library that addresses this topic. Later in March, the Moultonborough Library will host a workshop on fertilizer use near water.

Bob Clark recently sent out a pamphlet on chemicals, the water protection ordinances and Comprehensive Shoreland Act to all Moultonborough water front residents.

Wildlife Preservation

Marie Samaha said the program is set for March 8, 2010.

Wetlands Mitigation Projects

Paul Stinson, through discussions with a wetland scientist, Greg Howard, and Lori Summers of the NHDES, reported that there may be a way to address wetland projects in Moultonborough. Paul explained that the NHDES is interested in implementing a program that allows developers to mitigate filling in wetlands by completing wetland projects for towns in the same watershed. Paul said the rules or procedures for this program must be developed and the NHDES encouraged him to bring forward projects in an effort to initiate this program.

Paul proposed that he ask Greg Howard to write a Request for Proposals for a wetlands scientist to develop a list of potential wetlands mitigation projects for Moultonborough. Bob Patenaude seconded the motion and the members agreed to go forward with the RFP.

Land Use Change Tax

Milfoil Committee Report

An informational meeting about Moultonborough's Milfoil Initiative will be held tonight, March 1, 2010, at 7:00 in the Moultonborough Library.

Lion's Club Input to Planning Board

Commission and interested citizens had a lengthy discussion about the proposed project and its impact on wetlands and abutters.

The Conservation Commission made the following comments to the Planning Board. The Conservation Commission has the following concerns:

- 1. As a result of the project there appears to be significant alterations to drainage not only in the 17.5 acres of the project but in surrounding, abutting lots as well.
- 2. It is unclear how sensitive the project is to the aquifer as shown on the Natural Resources Inventory Water Resources Map at the junction of routes 109 and 25.

The Conservation Commission makes the following recommendations:

- 1. Urge Best Practices with regard to wetlands delineation and wetlands management for Phases 1, 2, and 3 before beginning Phase 1.
- 2. Obtain third party evaluation of wetlands, including drainage to abutting lots and their abutting lots.
- 3. Must have bathrooms and septic system designs for the soccer and softball fields.

The meeting adjourned at 6:30.
