

MOULTONBOROUGH CONSERVATION COMMISSION MEETING MINUTES OF 9/3/2013.

Meeting opened at 7 PM. Members present Marie Samaha; Chair, Bob Patenaude; Sec., Peter Jensen, Herb Farnham, Bill Gassman.

Alternates present: John Oliver, Ed Harrington

Others present: Robbie Parsons; NH Lakes Assoc., Shaw Smith, Moultonborough Academy.

Minutes of previous meeting were read and approved as is. Motion by Peter, 2nd by John. Unanimously approved.

CONSERVATION YOUTH CORPS: Robbie presented her proposal and explained in detail what it entailed and what monies are required to start. Discussion ensued as to what would be the “goal” of doing the projects outlined in the proposal. After much discussion it was decided that Ed will contact Jim Nelson from NY Lakes Assoc to focus on exactly what the benefits would be to Moultonborough. A motion to go forward with the project was made by Marie, 2nd by Peter that the Con Com would commit \$6000.00 this year. Robbie will come back with a new proposal showing what can be done with a \$6000.00 cap.

PERMITS/APPLICATIONS: Marie reported on the site visits she and Bob did last month. Bill observed what seems to be a violation within the rangeway bordering map180/lot 4. Con Com will investigate. Marie also reported on the site visit to map162, lot 87-1, where the owners inadvertently placed a leach field on a part of Town property. The board declined to accept a donation of \$600.00 for granting of an easement by the Town due to concerns of improprieties, and on a motion by Peter, 2nd by Ed recommended instead, that the homeowner have a certified septic design engr annually monitor the condition of the leach field. Unanimously approved. Marie will write a letter to the BOS stating our position.

The property next to Tedeschi’s Gas and Convenience Store was discussed. Con Com’s concern is placement of retaining wall.

MOULTONBOROUGH BAY INLET WATERSHED GRANT: Bill reported on his meeting with LRPC in which there was much discussion on how sewers have improved Lake water quality. Bill agreed to be the contact person for Moultonborough for the LWWA.

MONITORING EASEMENTS: Marie asked the monitors to take pictures of what they see.

WILDLIFE ACTION PLAN: No update available.

MPIC: Bob reported on the last meeting. Items of concern to the Con Com on the revised Master Plan seemed to be an oversight and will be corrected.

PRIORITIES/GOALS FOR CON COM: No update available.

MILFOIL UPDATE: Peter gave an update on the progress of treatments. (For further info see minutes of the Milfoil Comma).

COMMUNITY GARDEN: No update available.

There being no further business the meeting was adjourned at 9:30 PM. Motion by Peter, 2nd by Bob. Unanimously approved.

The next meeting will be on Monday, Oct. 7th at 7 PM in the Land Use Office of the Town Hall.
