## Minutes of Open Meeting Trustees of the Trust Funds

## Moultonborough, NH

July 13, 2010

Chairman Taylor called the meeting to order promptly at 3 PM.

All three Trustees, Ken Taylor, Jordan Prouty and Jack Porter were present. Also attending was Ann Carlson, VP of Business Development for the Meredith Village Savings Bank (MVSB). No other interest parties were present.

Jack Porter made a motion, 2<sup>nd</sup> by Jordan Prouty, to accept the Minutes of the May 25<sup>th</sup> Meeting. Minutes are now being distributed via e-mail.

Chairman Taylor thanked Ann for attending and asked her to give a brief overview of the MVSB and our interest structure. Ann reported that a survey of finiancial institutions showed they were paying 0.6% but that the MVSB will keep our rate at 0.9%.

Jordan asked Ann if we could get a better interest rate, in particular, for the Duclos Fund, Chellie Environmental Fund, Miller Env. Fund and the Moultonborough Children's Fund. Jordan explained these were private funds and the funds were used for educational purposes. Ann reported we could place them in a CD at a rate of 1.05% but we were limited to a one time withdrawal. She suggested we look into the MVSB gift request form or application which could be used to assist in improving the monies for educational purposes to the above funds. Ann suggested we write to the MVSB and have all three Trustees sign it. The Trustees will give this further consideration during our next meeting.

Jordan reported the Trustees current invested funds for the period ending 6/30/10 at \$2,423,529.97. Ann Carlson confirmed the amount. The interest gained from 1/1/10 thru 6/30/10 is \$10,467.84.
