Project Reports and discussion

• Lake Hosts:

Paul Ardito has distributed a proposal for the job posting for Lake Host. The minimum age is 16, which is a rule from the NH Lakes Assoc. Paul D. made a motion to approve the Job Posting as written with a possible change to the rate when it is pegged to town rate. The motion was seconded by Ginny and unanimously approved.

Paul A. will speak to Superintendant Mike Lancor and Principal Andy Coppinger about getting the lake host job posting in Paw Prints and otherwise posting at the high school.

The committee discussed the idea of raising the hourly rate for lake hosts to \$10.00 or \$10.50 per hour. Jim suggested making the rate the same as the town. Paul D. moved that we raise the rate and peg it to the town. Ginny seconded, and the motion was unanimously approved.

Ginny will send Paul A. the information gatherered at the Feb 7th informational meeting re: people interested in volunteering as a lake host.

• Weed Watchers:

Work on documenting the areas covered by volunteers is ongoing.

• Milfoil Abatement and 5-Year Plan: No update

Paul D. developed a policy related to herbicide objectors. Paul A. made a motion to approve the policy, seconded by Karin and unanimously approved.

Marc B. of ACT has made an inquiry if we are ready to proceed with the next planned herbicide treatment. He wants to get started on the permit process since there is a 90 day leadtime. The treatment plan includes 34 acres in the Phase II/III areas, 100 acres to retreat in Phase I areas and the 35 acres not treated at Wentworth Shores. The town has agreed to move forward with this in Spring Treatment. Amy has said she'll have the area surveyed

before the first letter goes out. Paul D. proposes going back to Amy to give us direction on going forward on the permit process, especially as regards the abutters. The process needs to start in 2-3 weeks.
