Lots of floaters have been found that are partially dead with new shoots coming off the stem. Members of the committee will talk to Ken Marschner, Amy and divers to find out if we need to get the dead treated plants out of the lake because of the possibility that new milfoil may grow from them.

### Weed Watchers

Ginny will continue to consolidate Weed Watchers input onto the ARCGIS map. In the next two weeks she will send a report to weed watchers and also ask them to characterize milfoil by a Level 1-2-3 scheme as follows:

**DRAFT Weed Watcher Milfoil Rating** 

	•
Description	Characteristics
Level 1	In a 500 sq foot area there are 1 to 10 plants
Level 2	In a 500 sq foot area there are more than 10 plants but you can see spaces between them
Level 3	In a 500 or larger sq foot area there is a mat of plants with no spaces between them

Paul will ask DES for their input on the above designations of infestation levels.

We will also ask weed watchers to tell us how deep the water is where they have found milfoil.

Obviously, in terms of scheduling treatment/harvesting, we will address the most complete information first.

We discussed sending the weed watchers photos help them identify densities.

The weed watcher map will indicate what level rating the weed watcher has reported.

It was discussed that we should identify gaps in weed watcher coverage and recruit more weed watchers via the associations.
