Karin will speak to her contact at public radio about getting some coverage on picking up floaters as well as all areas of volunteering for the milfoil program.

In addition, Lake Hosts could be instructed to educate boaters about the milfoil monitors program. A 3X5 card with information could be handed out.

Ginny will create some reusable text about what to do with the fragments.

III. Continued Business:

- **Five-Year Plan**

Amy will not be out on the lake to survey until mid-May. She estimates we will have completed the survey by the beginning of June. Paul A. is concerned this is not early enough to plan a June herbicide treatment.

Bev has spoken to Amy who said she's done everything she can to open the way for treating the Lee's Pond area that was not treated last year due to bridle shiners.

- **Lake Hosts:**

Paul A. reported that no high school students have applied to be lake hosts. However, all but 3 of last year's volunteers have agreed to come back.

One of last year's very good paid lake hosts will be coming back and she will be focused on Long Island.

Paul thinks by the end of next week they'll be done with staffing.

July 4th falls on a Wednesday. Paul plans to staff all week, but not heavily. He is assuming people will be taking the entire week off and that we can expect a lot of boaters.

- **Weed Watchers**

Bev found a huge amount of fragments at Lee's Pond.

Bev's weed watchers training is Saturday, April 28th at the library at 10 am. She's not sure how many will be attending.

Bev has four association meetings at which the MMC is schedule to speak. Bev has not had responses from additional associations. She would like to sit down with someone who has more knowledge of the names on the list.

She will divvy up the phone numbers on the list and each of us will make calls on the association list.

After the training, Bev will come up with the list of areas which are not currently covered by weed watchers.

- **Tri-Town DASH Initiative (MJB)**

The 60 day out-clause has been removed from the NH Lakes contract and the contract is now signed by AB aquatics.

Boats are being readied for a mid-May launch.

Al is working on scheduling the survey with AB Aquatics for before Memorial Day if possible.
