Special meeting called For Wed., June 30th 2014 @ 4:30 PM @ the Town Hall


Members Present: Chairman Karin Nelson, Al Hoch, Bev Nelson, Scott Bartlett, and Paul Daisy

At 5:00 p.m. Amy Smagula of DES and Mark Ballard of ACT jointed the meeting.

- Mark was asked about treatment date and it is scheduled for July 17th. The chemical to be used is "Navigate." Mark will pull the list of abutters and send the certified letters.
- Al and Karin went over planned areas and our concerns with Mark and Amy.
 - Area A OK as marked on map
 - Area B needs to be extended. (Loon nest not an issue as it is empty)
 - Areas C & D are OK as marked on map
 - Delete area E for treatment. This 7.12 acres was treated last year. Can be managed by pulling this year.
 - $\circ~$ Area F is a 6X15 ft dense patch and can be dashed. No treatment needed.
 - Area G should be treated and even make bigger. The shoals are an issue here.
 - Add Area H (shoals area off Balmoral) for July treatment.
- A discussion followed concerning treatment in shoal areas that continue to be an issue getting chemicals to work. It was decided to setup a test area using curtain barriers and bottom barriers. Mark and Al will follow up on this.
- Al will send Amy GPS points on revised areas. Amy will send out updated map.

Conference call with Mark and Amy ended at 5:40 P.M.

Committee had a discussion on how we are trying to get the best value for our money.

Paul Daisy made a motion to adjourn at 5:45 p.m. Seconded by Al Hoch.
