Three Selectmen and secretary present.

The Selectmen met with town counsel, David Nixon, at 7:00 pm. Fire Chief, James Dodge, was present with John Bunting. First of all, Mr. Nixon brought the Selectmem up to date with the proceedings of the John RASSIEVICZ case. It is hoped that this case can be dismissed as being considered too frivolous for litigation.

The next subject for consideration was the case of the Fire Dept. having inspected the Molly Stark Tavern for fire hazard and have asked the owner, Louis Maynard, to make corrections, giving him to December 13 to comply. They report that he has made some corrections but refuses to paint the interior of the restaurant with fire-proof paint. Mr. Maynard would prefer an inspection by the State Fire Marshall and has agreed to abide with his regulations within 60 days. It was stated that the Fire Marshall will only enter at the request of the Selectmen. The Fire Marshall had agreed to do the inspection but only if Fire Chief, James Dodge, would sign the permit. Chief Dodge refused because it was not his inspection. Atty. Nixon has corresponded with Mr. Maynard's xxx attorney, Mr. Shapira, and suggested that the firemen try to settle this dispute amiably and hoped the Selectmen would explore all avenues for a reasonable settlement to prevent this case from going to court causing a big expense to the town. Sel. Olson asked what would happen if the Fire Chief signed a permit for the Fire Marshall's inspection and then a fire occurred at the Tavern. Mr. Nixon said under these circumstances, Mr. Maynard would be responsible for the negligence. In reference to the number of occupancy, the firemen said if the interior were painted with the special paint (\$50 a gallon) the occupancy figure could go to 102.

The firement asked for Mr. Nixon for his professional water opinion. He suggested the Selectmen weigh all items and offer some compromise. The Selectmen asked Mr. Nixon to ask the Liquor Commission not to remove Mr. Maynard's license. Mr. Nixon suggested the firemen prepare a letter that he can deliver to Mr. Shapira offering the "bottom line" on the inspection.
