MINUTES: Dave made a motion to accept the minutes of September 18th as amended. Gordon seconded the motion, all in favor.

APPOINTMENT:

7:00PM Brenda Linde Conservation Footbridge

Brenda Linde was present to give the board an update on the installation of the footbridge. The bridge is constructed of self-weathering steel and pressure treated wood, which needs no paint. It has a 75-year life span, excluding the wood. Conservation needs to raise another \$4000.00 to cover the cost of the bridge, which should be reached by the end of October. Saturday, October 28, 2000, will be the dedication ceremony.

OLD BUSINESS:

- 1) Planning Issues There will be no meeting this week.
- 2) Department CIP Proposals -

Police - Same proposal as last year. Department would like to move forward with some portion of last year's warrant article; (A/C, monitoring, recording equipment, desk console, cell completion).

Planning, Conservation, Forestry - submitting last year's proposal. **Recreation** - A proposal was made for a separate recreation building in the event that the Library/Recreation Center plans are not passed. Estimated cost is approximately \$50,000.00.

Transfer Station - Bonnie is waiting for prices on equipment in her proposal. Trailer options are being reviewed.

3) Library Expansion - The next step would be to find out the market value of the most desirable properties and to see if they are available for purchase, legally. If available, then negotiations would follow. Dave made a motion to appoint Leslie Nixon as the official contact person, in conjunction with the town administrator, to determine the five criteria in the presentation of the library. Mark seconded the motion, all in favor.

- 3) Finance Schedule & Budget Procedure The finance committee holds meetings, which the selectmen attend if they wish. Issues are discussed at the meetings. Minutes of the meetings are available for those who cannot attend.

OTHER:

- 1) Holden's Proposal Burton will be signing a proposal to authorize work that will be done for Lee Murray.
- 2) A letter is being sent from the Board of Selectmen to Gregg Young of Cemetery Road regarding a large bush that is obstructing the view of traffic.
