# **Meeting Minutes**

The Meeting was called to order by Jeffrey Hughes, Chairman, at 4:30 pm.

### Welcome

Mr. Hughes welcomed committee members and guests to the meeting.

# **Approval of Minutes**

The Committee reviewed and unanimously approved the Minutes of the previous meeting

# **Road Study**

Mr. McDonald presented updated draft spreadsheets model of the long-range road program. Three alternate funding models were presented for the Committee's consideration:

- A) Funding @ \$80K for FYs '17 & '18; funding at \$70K for FYs '19 and beyond
- B) Funding @ \$100k for FY '17; funding @ \$70K for FYs '18 and beyond
- C) Funding @ \$70K for all FYs

The Committee members discussed the three models in light of developing a recommendation to the Select Board for initial funding of a long-term road program. Following a discussion, the consensus of the Committee was support for initial funding for FY 2017 in the amount of \$80K. Funding at this level would cover the projected costs of road repair, and leave a positive ending balance of approximately \$13K - - thereby establishing the long term road fund by setting aside funds in a "savings account" for the future.

#### FINAL

#### V&E Fund

The Committee members began to discuss the V&E Fund. The Committee began with a review of last year's spread sheet.

The committee affirmed the assumptions of 2.0% inflation rate, and 1.5% dividend rate. The estimated current balance of the V&E Fund is \$296,763. The Committee reviewed an email from Fire Chief Blanding recommending changing the request for a Ladder truck to an engine, and changing the useful life of all of the EMS equipment from 8 years to 10 years.

The Committee questioned the amount of funding for the Fire Engine, Mr. Hughes agreed to follow-up with Chief Blanding.

Mr. McGuckin agreed to reach out to Police Chief White to remind him of the need to update the V&E Funding assumptions for Police vehicles.

Mr. McDonald was asked to continue his work at updating the V&E Fund.

# **Other Business**

There was no other business to come before the Committee.
