## Approved Firewards Minutes of January 12, 2016 Meeting

Subject: 6 Month Update on Weekend and Holiday Part-time Shifts

Per your request, the following information is provided for your perusal. In my opinion as Chief of Department, the weekend and holiday part-time shift coverage has been a complete success and a tremendous value to the town. It is certainly money well spent!

All shifts have been filled on Saturdays, Sundays and Federal Holidays, including Thanksgiving and Christmas. Members of the department have certainly stepped up and ensured that shifts were filled and the town was covered.

25 Emergency Calls occurred during these shifts. Some examples are: a serious bicycle accident on the Wentworth Bridge. A boat collision at the Wentworth Bridge resulting in a serious head injury to one of the passengers. An elderly female found by a passerby down on the ground on the side of the road with hypothermia. Two fire alarms at two separate houses within a 30 minute period that were responded to immediately by Engine 4 with a four person crew. A 30 second response time for a person found down not breathing. Mutual Aid to Rye for a person down at Odiorne State Park. A Fire Alarm at the Wentworth Hotel. An elderly person who inhaled bug spray. A broken water pipe flooding a house. A walk -in Medical Aid call at the station. All of these calls were responded to quickly and professionally.

While on duty, the members have performed vehicle maintenance and checks, equipment maintenance and checks and building maintenance. I have attached Daily Logs for every shift and a Call Summary.

They have concentrated on training and education with some senior members coming in to work with them on their qualifications. I have noticed a marked improvement of the abilities, knowledge and competence of the members, who participate in the weekend shifts, during the performance of their duties during actual operations, drills and exercises.

Overall, I think the morale of the department has improved with most members becoming more active and involved with department activities. Sincerely, David M. Blanding
