#### New Durham Board of Selectmen Work Session Wednesday, September 7th, 2011 Town Hall

The Board of Selectmen's meeting was called to order at 9:05AM.

**Present:** Theresa Jarvis, David Bickford, Jeffrey Kratovil **Also present:** Steve Bedard of Bedard Preservation, Town Historian Cathy Orlowicz and Town Administrator Alison Webb Joan Swenson joined the meeting at 11:11AM.

The Board of Selectmen and Town Historian Orlowicz took Steve Bedard on a tour of the Town Hall to begin the process of the Historic Building Assessment. Mr. Bedard will be performing a structures report, and the Board and Mrs. Orlowicz provided him with information on the needs of the 1907 building, and background information.

Selectman Bickford and Selectman Kratovil met with Joan and asked her a series of questions in relation to her interest in the ZBA and her professional background.
