Roll Call: Charlie Berube (Vice-Chair), Bill Malay (Acting Chair), Terry Jarvis (Selectmen's Representative). Excused: Cathy Allen (Chair), Bob Craycraft (Alternate).

O'Neill: The commission reviewed application cc.2010.23 of Hugh and Joan O'Neill for a Minimum Impact Expedited permit at 325 Merrymeeting Road (Tax Map 118-045). No concerns were expressed. Terry Jarvis moved to send the application on to NHDES without concerns. Bill Malay seconded. Approved 3-0.

Gilson: The commission determined that the application cc.2010.28 is incomplete. Terry Jarvis moved to set aside the Standard Dredge and Fill application of Jeffrey & Patricia Gilson at 234 South Shore Road (Tax Map 112-004) until it is complete. Bill Malay seconded. Approved 3-0.

3 applications listed on the agenda for Sawyer, Brackett, and Dreyer were acted on at the August meeting.

Abizaid: The commission reviewed application cc.2010.25 of Charles Abizaid for a Minimum Impact Expedited permit to reface concrete wall, replace existing patio with pervious patio paver, and repair retaining walls at 13 Meaders Point Road (Tax Map 111-041). No concerns were expressed. Terry Jarvis moved to send the application on to NHDES without concerns. Bill Malay seconded. Approved 3-0.

Willard: The commission reviewed application cc.2010.27 of Marilyn Willard for a Minimum Impact Expedited permit to repair retaining walls at 15 Meaders Point Road (Tax Map 111-040). No concerns were expressed. Terry Jarvis moved to send the application on to NHDES without concerns. Bill Malay seconded. Approved 3-0.

Williams: The commission reviewed application cc.2010.26 of George Williams for a Permit by Notification at 240 South Shore Road (Tax Map 112-006). No concerns were expressed. Bill Malay moved to send the application on to NHDES without concerns. Terry Jarvis seconded. Approved 3-0.

Federal Wetlands Reserve Program: Bill Malay updated the Commission on the availability of federal funds for the Wetlands Reserve Program which can be use for the protection of large tracts of wet lands and surrounding high ground. Natural Resources Inventory: Bob Craycraft reported that Forest Bell Environmental has been selected to perform the town's natural resources inventory and he is ready to begin. Before starting he would like to meet with members of the Conservation Commission and the Planning Board to review his plans and get input and comment.
