Employers who have a current (2011 or later) Safety Summary Form on file with the NH Dept. of Labor will not be required to file again. Employers which have not filed a Safety Summary Form since 2010 or have never filed a before are subject to the requirements of the revised law. After New Durham's 2012 Safety Summary Form is filed we will not have to file again.
- B. Primex NH Public Risk Management Exchange training information was share. Jeremy Bourgeois will distribute the information to Department Heads. Carole Ingham will arrange the "Joint Loss Management Committee Primer" training within the next few months.
