Call to Order/Agenda Review: Lee Newman, Trustee Chair, called the meeting to order at 7:07 p.m.

Approval of Minutes:

Director's Report and Informational Items:

Cathy Allyn reported that May 2016 children's programs continued with **First Steps, Storytime, Kindergarten Kapers, and Cubelets.** Due to low interest in **Cubelets** the program will not be revisited for now. Book bag decorating Party for **"1000 books Before Kindergarten"** program was successful with 22 attending. **GoldieBlox** program scheduled for July. Adult programs included **Mystery Book Club, ACT, Oil Painting, Pencil Me In, Book Club, Oh,Well! and Raised Bed Gardening** were well attended. Program "Color me Calm" was cancelled due to lack of participation.

May statistics show a drop in attendance compared to May 2015, Ebooks showed an increase over May 2015. Total circulation down slightly compared to May 2015.

Book-Bake and Plant sale scheduled for June 25th 9am-12pm with help from Library Friends.

Installation of HVAC mini-splits to be scheduled.

TDS donated \$500 to fund "Stories Sung in Clay".

July 13th "Marvelous Marvin" entertainer funding. Motion made by William Meyer to pay \$375 from Trustees Account to pay for Marvelous Marvin if funds not available from programming. Seconded by William Kendrick, motion passed.

Other action:

Richard Leonard will sponsor the ND Library in the "Paint a Pig" contest (adult category) hosted by the Alton-Barnstead-New Durham Rotary club. Contest is a fundraiser benefiting Meals-On-Wheels. Motion made by William Meyer that trustees sponsor same in the children category for \$75, seconded by William Kendrick, motion carried.
