Call to Order: Vice-Chairman Craycraft called the meeting to order at 7:12 pm.

Public Hearing (7:14 p.m.) - CONDITIONAL USE PERMIT - Goodrich - Map 110, Lot 27

Mr. Craycraft read the following from the public hearing notice:

"Regarding an application submitted by Thomas Varney, PE on behalf of Freeman and Joan Goodrich for a conditional use permit to allow the disturbance of 7,122 square feet in order to demolish the existing cottage, construct a new home with attached garage, and installation of a well. The property in question is located at 375 Merrymeeting Road (Map 110 Lot 27) in New Durham, New Hampshire. The public hearing may be convened if the application is accepted as complete."

MOTION: "To accept the application as complete" by Mr. Anthes, 2nd Ms. Chabot.

Motion passed 3-0.

On behalf of his clients, Mr. Varney outlined the details of the conditional use permit application. There was no public input regarding this application. Planning Board member Dot Veisel arrived midway through the discussion. Mr. Craycraft closed the public hearing at 7:29 p.m.

MOTION: "To approve the conditional use permit" to allow the disturbance of 7,122

square feet in order to demolish the existing cottage, construct a new home with attached garage, and installation of a well. Motion by Theresa Chabot, 2^{nd} by Gregory Anthes. The motion was **approved** with three affirmative votes (Theresa Chabot, Gregory Anthes, and Robert Craycraft) and one

abstention (Dot Veisel).
