Master Plan Update

Ms. Veisel finalized posting to put on website and disseminate to Town employees and businesses. Mr. Swenson noted that he spoke to the car dealership and gun shop in town inviting them to the meeting. Ms. Veisel discussed her projections from data and demographic observations and her hopes that the other board members will form similar projections on this data as they have different perspectives than she does.

Chairman Drummey looked for input on how we could compare data with other surrounding towns that may have input. Ms. Veisel noted that she did invite the regional transportation authority of the county. Chairman Drummey explained his opinion of added bicycle lanes to enhance alternative transportation uses but the cost and liability need to be evaluated. Further discussion included a sidewalk from

the school to the ballfield and a Park & Ride lot close to Rt. 11. Much discussion of Rt.11 safety measures were mentioned.

Chairman Drummey organized a plan for how the Transportation Forum will be run and who would be responsible for what portions of the discussion and for presentations. Mr. Swenson will be running slideshow, Ms. Veisel and Chabot will be working with easel and discussions with attendants, Chair Drummey will be coordinating flow of forum. General discussion topics will include Tourism, Bicycling/alternative transportation, resident issues, business issues, accident prone areas.

Other Business:

Ms. Veisel spoke on attending the Board of Selectmen Meeting and speaking to a resident that was considering subdividing his property on Jenkins Road. He was denied a driveway permit but she offered the opportunity for him to come speak to the Board and have an informal discussion on the subdivision.
