## **CKC Director's Report:**

- Laura notified PRC that she has surgery scheduled for June 5<sup>th</sup>. Shay Bennett was introduced to the board. She has completed the hiring process and has accepted a position as CKC sub for a trail period of 6 months.
- Laura distributed copies of Summer Program Calendar, accident reports, and PO's for signatures.
- Dot distributed copies of the revised CKC Agreement/Contract which outlines new fee schedules and changes in policy. Sherri B presented a request from parents for part time summer hours. Agreement was amended to provide this option. The Hiring Policy and the revised Rules and Procedures were also distributed.
- For clear record keeping, Dot advised Laura that all leave time must be requested in writing in advance and be approved by the PRC. Sick days need to tracked and noted on her time card and reported to PRC. Laura agreed saying she has been doing this all along but will highlight these absences on the time card.

- Sheri Joy has contacted the Ron Jones Band for the Barn Dance to be hosted by Patty Lucerne as a fund raiser. She presented several fee options. There ensued considerable discussion of liability issues surrounding BYOB conditions of a party on private property. It was agreed to pursue clarification of regulations from NDPD. Date of dance is June 30<sup>th</sup> and admission fees will be \$15 for single and \$25 per couple. Kellie will advertize on Rec sign at the land at Transfer Station, on face book, weekly in the newspaper. Jen will make posters, distribute them and request clarification and permit from PD. Marcia will have tickets printed and they can be picked up from her.

Motion to hire Ron Jones Band for \$700 pending permits and NDPD clarification of legal issues by Jen and seconded by Marcia. Passed unanimously.

- Kellie announced Town Wide Yard Sale is scheduled for June 9th.
- She has ordered banners for parade for \$24.
- A notice from LGC citing some issues with the playground at the ball field was passed around. Tabled.
- Water Pump at the ball field is broken. A representative (Keith) from Triple A
  Water has checked it and will repair it, charging us just for parts.
- Kellie asked PRC for guidance/feedback on the issue of fingerprints and background checks for coaches. She has paperwork requesting just State background check for \$10; and forms requesting fingerprints and State and Federal background checks for \$25. PRC authorized her to use shorter form just requesting State background check for baseball season. The issue will be revisited to determine a policy.
- Sherri B requested that PRC provided a uniform for coaches. It was agreed to supply a generic shirt with printed "New Durham Coach" which can be used for all teams and sports.

Motion to order tee-shirts in a variety of sizes for coaches made by Marcia and seconded by Sheri J. Passed unanimously.
