- 2. Department of Revenue Administration Letter. The DOR has requested information about the:
 - Town Hall ADA CRF:
 - Fire Department Truck Replacement CRF/

At the 2003 Town Meeting (Article 11) the Town voted to discontinue the Fire Department Truck Replacement CRF.

- 3. TOTF Investment Policy. Based on a review of the New Durham TOTF Investment Policy SB 377 will have no effect. TOTF reviewed all the required documentation.
- 4. Review of the current investment policy. This was postponed until the next TOTF meeting. In the future the TOTF will invite Banks to make presentations to the Trustees. Any one with any suggestions of who to invite should contact Bookkeeper Allyn.
- 5. Next meeting: After reviewing the Trustees schedules the next trustees meeting will not occur at least the end of September. All Trustees are to let Bookkeeper Allyn know of their availability for a meeting from 9/22/08 10/15/08
- 6. Report of the June Trustees of the Trust Fund Seminar. Ms. McHale stated that all the relevant information was in the book that she received. She has previously distributes copies of the book to the other 2 Trustees.
- 7. Ethics Statements: Both Ms. McHale and Ms. Jarvis have previously signed the Ethics Statement. Bookkeeper Allyn signed the statement during this meeting.

13. Tax Maps. The Board of Selectmen have requested the TOTF transfer \$ 234.00 to the general find for the purpose of paying the Strafford County Register of Deeds. None of the Trustees understood what this payment was for.

14. Tax Maps. The Board of Selectmen have requested the TOTF transfer \$ 11,000.00 to pay for expenses associated with the new Property Tax project. After reviewing the latest figures in this CRF it was determined that there are insufficient monies available to transfer.

Motion: The Bookkeeper will notify the Board of Selectmen that we cannot honor their request due to insufficient funds in the CRF. T.Jarvis/M. McHale Passed 3-0

15. Copple Crown request. The Copple Crown request, received 8/20/08, is for payment for work associated with upgrading their water system. After a lengthy review of the submitted documents the TOTF funds were unable to understand them

16. Request for monies from the J.C. Shirley Charity Trust fund.
