Nancy- will get the mail at the town & post meetings – meeting must be posted 48 hrs in advance on Town website & in the Town Hall

Jan – take minutes & type up drafts – after approval, send to Sue Noyes to put on Town website.

"Rack Cards" Advertising Schoolhouse - Eva express an interest in helping drafting up a prototype.

- Media "person" Eva expressed interest in looking at creating Facebook page; helping with the Historical Commission 1635 website (after we get access passwords).
- 2. We are going to set up the 2 informational forums for the public on the DDB prior to the Special Town meeting. The BOS voted to put the DDB on the warrant at the 07/22/14 meeting. Martha Taylor will assist us with getting these set up & notifying the newspapers.
- 3. Sails & Trails needs a liaison for upcoming/future Historical events. Lon & Eva both express interest in contacting them. A vote was put out to not be part of the even this September and was passed with a unanimous approval.
- 4. Town will be posting our need for a new member sometime after October.

The next meeting of the Historical Commission was not discussed, as the Public informational discussions will be held in October and we did not have any open items until after the Special Town Meeting on the 21st.
