Capital Reserve is \$1,900.44 as of July 1, 2012. Discussion followed regarding the transferring of funds between line items to close out the fiscal year.

Burgess Kenyon made a motion to transfer \$2,416.50 from Trees & Tree Maintenance to Consulting, seconded by Burgess Baiad and unanimously approved.

Burgess Kenyon made a motion to transfer \$2,009.08 from Trees & Tree Maintenance to Streets & Parks, seconded by Burgess Lucas and unanimously approved.

Burgess Lucas made a motion to transfer \$457.81 from Trees & Tree Maintenance to Data <u>Processing</u>, seconded by Burgess Kenyon and unanimously approved.

Burgess Kenyon made a motion to transfer \$44.69 from Auxiliary to Data Processing, seconded by Burgess Baiad and unanimously approved.
